4. Responsibility & Liability for Damages

The Renter is responsible for any damage, loss, or theft of the equipment during the rental period and agrees to cover the full cost of repair or replacement, including damages beyond normal wear and tear.

5. Loss or Failure to Return

If the equipment is not returned within ____ days of the agreed return date, the Lessor reserves the right to charge the full replacement value of the equipment.

6. Indemnification

The Lessor is not liable for any injuries, damages, or losses incurred by the Renter or third parties during use of the equipment. The Renter agrees to indemnify and hold harmless the Lessor from any claims arising from use.

7. Cleaning & Condition Upon Return

Equipment must be returned in reasonable working condition. Excessive dirt, misuse, or required servicing beyond normal use may result in additional fees.
